- Coach must be USFS/PSA approved in order to coach student at test session.
- This application must be delivered (NOT postmarked) to the test Chair on or before the posted due date, along with the total test fees. Application not valid unless test fees are attached and signed where indicated.
- Fees are NOT refundable unless the test is cancelled by the CLUB. Refunds must be approved by the SSC Board. Fees will be forfeited if the skater does not appear at the scheduled time.
- If the number of tests exceeds ice availability, SSC members will receive priority in the following order: 1) Tests needed for qualifying events 2) Tests needed for non-qualifying events 3) All others a) in order from highest to lowest level b) in the order in which they were received.
- Skaters should arrive at least 45 minutes before their scheduled warm-up. (not necessary for first warm-up group)
- The test schedule will be posted, at the rink, at least 4 days prior to the scheduled test.
- Charges for critiques are the same as the test fees. Moves-in-the-Field are not eligible for critique, unless otherwise specified. Critiques for long and short programs EACH require a fee.
- USFSA members in a club other than SSC, *MUST* have a letter of permission from your Home Club's duly authorized representative as stated in TR 1.028 of the USFSA Rule Book.
- Out-of-Club Test Fees do not apply to any skater whose Home Club is a member of ILLINOIS SKATING COUNCIL.
